President's Message

Veterans Claims

You will recall that toward the end of January Congressman Doug LaMalfa and two members of his staff, Jennifer Horne and Jenna Batti, met with several members of our chapter who were encountering difficulties with their VA claims. Jenna attended our chapter meeting on March 7 to follow up. The sense I am getting from our members is they are making progress with Jenna's help. If you need to speak to Jenna, her telephone number is 530-534-7100. Claims from our area are processed through the VA processing center in Oakland. The following report from the Veterans Administration as of February 11, 2013, showing the average number of days disability claims are pending for Oakland compared to the average for all processing centers nationwide demonstrates the need for improvement in Oakland.

Pending Disability Claims

Oakland has 31,518 disability claims pending an average of 452 days. Of those, 25,761 (87.9%) have been pending more than 125 days, and 19,678 claims (72.8%) have been pending more than one year.

Oakland has 7,827 disability claims pending initial development. Average days awaiting development is 192.4 days.

Although the VA recommends the best way to file a claim is to file a Fully Developed Claim and register for eBenefits at https://www.ebenefits.va.gov/, most vets will receive better service presenting their claim through our Veterans Service Office in Grass Valley.The staff at the VSO can help you determine if you are eligible for a Fully Developed Claim and help track the status of the claim. Jenna Batti 's function is to help push your claim along if you are having difficulty getting your claim resolved. If your claim doesn't seem to be progressing, through her contacts in the VA system she can often find out why and get it moving. So, if you have had a claim pending several months and, in some cases years, give Jenna a call.

Vet Gun Control Update

Senator Feinstein has set off a fire storm of controversy and debate over her remarks at a recent Senate Judiciary Committee meeting that were against expanding the exemption from a gun ban for retired military veterans.

I am a reasonable person and usually can excuse an ignorant statement from an average person because, let's face it, we do not have time to learn all there is to know in this universe. However, when a Senator of the United States makes ignorant remarks concerning policies that would inhibit any of our God given rights in the Bill of Rights I take issue. In a recent Senate Judiciary Committee meeting regarding her proposed gun ban legislation, Senator Dianne Feinstein (D-California) made a statement so ignorant it reminded me of how unimpressive, unprofessional, and dangerous ill-educated people with a high opinion of themselves can be when put into office. If you as a legislator who is entrusted with the future of the United States do not take the time to consider your words and become educated on the topic for which you are addressing you have no business being in your position. Here is the statement that has caused alarm to not only myself but many in the veteran community including vocal and respected veteran's advocates.

"SEN. DIANNE FEINSTEIN: If I understand this, this adds an exemption of retired military. As I understand our bill, no issue has arose in this regard during the 10 years the expired ban was in effect and what we did in the other bill was exempt possession by the United States or a department or agency of the United States. So that included active military.

The problem with expanding this is that, you know, with the advent of PTSD (Post Traumatic Stress Disorder), which I think is a new phenomenon as a product of the Iraq War, it's not clear how the seller or transferrer of a firearm covered by this bill would verify that an individual was a member, or a veteran, and that there was no impairment of that individual with respect to having a weapon like this.

So, you know, I would be happy to sit down with you again and see if we could work something out but I think we have to-- if you're going to do this, find a way that veterans who are incapacitated for one reason or another mentally don't have access to this kind of weapon." Her remarks were in response to a proposed amendment that would exempt military veterans from her gun ban legislation. The exemption was supported by Senator John Cornyn (R-Texas). In response to Feinstein's statement, Shawn J. Gourley a founder of Military with PTSD, issued an open letter that has begun to go viral via social media.

"First of all, Senator Feinstein, PTSD is not a, "new phenomenon as a product of the Iraq War." It has been called soldier's heart in the Civil War, shell shock in WWI, battle fatigue in WWII, and only most recently, post-traumatic stress disorder, or PTSD. PTSD made its first appearance in the Diagnostic and Statistical Manual Third Edition, which was published in 1980. The doctors who lobbied for its inclusion viewed it as a measure that would finally legitimize the pain and suffering of Vietnam War veterans. However, adding PTSD to the DSM turned out to be an action with more far-reaching effects than just that population; it opened doors for a lot of people who desperately needed help. PTSD is a psychological reaction that occurs after an extremely stressful event involving the threat of injury or death. Anyone can get PTSD at any age. This includes war veterans, police officers, firemen, and survivors of physical and sexual assault, abuse, accidents, disasters, and many other serious events. So as you can see, Senator, with all due respect, PTSD is not exclusive to either veterans in general or specifically veterans of the Iraq War. "

This is only an excerpt and I encourage everyone to read the full letter available on CNN ireport. Shawn's response was professional and tempered considering the ire we all felt when hearing the Senator's comments. Senator Feinstein missed the meat of many of her points but namely this statement caught my eye. "it's not clear how the seller or transferrer of a firearm covered by this bill would verify that an individual was a member, or a veteran, and that there was no impairment of that individual with respect to having a weapon like this. "

First of all, there is a very easy way to find out if an individual was a member of the armed forces. It is called a DD-214 and I highly doubt any veteran would be opposed to providing that information to a registered firearms broker if it meant they could get certain guns they wish to own. If Feinstein were serious about this, she would put extra personnel and funding into the National Archives to make DD-214s more quickly accessible or, and this is a wild thought, make sure that information is accessible in any background check which are already required by law to receive a gun. Everything she is worried about is already covered by the National Instant Criminal Background Check System or NICS.

Gun Cintrol Continued Continued "Who Cannot Buy a Gun?

Persons who may be prohibited from purchasing a firearm as a result of data obtained from the NICS back-ground check include:

- Convicted felons and people under indictment for a felony
- Fugitives from justice
- Unlawful drug users or drug addicts
- Individuals who have been determined to be mentally incompetent
- Illegal aliens and legal aliens admitted under a non-immigrant visa
- Individuals who have been dishonorably discharged from the military
- Persons who have renounced their American citizenship
- Persons under domestic violence restraining orders
- Persons convicted of misdemeanor domestic violence crimes

Between 2001 and 2011, the FBI reports that over 100 million Brady Act background checks were performed; resulting in more than 700,000 gun purchases being denied."

Secondly, Post Traumatic Stress Disorder does not mean you are automatically incapable of wielding a firearm especially if one is a veteran. Veterans are far more trained to own and properly use a weapon than most of the average population. In Shawn Gourley's letter to Senator Feinstein she points out that some police officers can and do have PTSD. Police officers with PTSD are still working where they are required to use force if the need arises. Being consistent with Senator Feinstein's line of thought would cripple the American police force and is highly unreasonable. In her effort to remove guns from America, it seems she is willing to place civilians in harms way as well as undercut all the efforts and progress Americans have made in helping veterans seek help for Post Traumatic Stress Disorder. If PTSD becomes a determining factor in whether or not you can keep your second amendment rights it is quite probable that veterans and many civilians will no longer seek treatment.

The reasons Shawn stated in her letter as well as the reasons I have pointed out are just the tip of the iceberg that demonstrate how far Dianne Feinstein's remarks are from reality.

Agent Orange and Later Toxins

While we've always known that "War is Hell!", it's gotten even worse, as a large part of that Hell, is self-inflicted. As if the danger of being shot and hit, or catching shrapnel, stepping on mines weren't bad enough, our military has chemicals to worry about.

In WW I (The war to end all wars), it was the Germans gassing their opponents.

Towards the end of WW II, at the behest of our military leaders, chemical companies came up with a means to defoliate large plots of land. The intent was to clear landing spaces, and also to eliminate hiding places used by the enemy.

Wide-spread usage of these defoliants didn't occur until our involvement in Southeast Asia, where the jungle provided cover for the VC and NVA.

Of course, there was also the usage of these chemicals to clear vegetation in and around our bases.

Not generally know at the time, was the fact that it was also being used, not just in Vietnam, but in other countries, as well. Including the United States of America!

Initially, a serviceman or woman was required to PROVE that they had been exposed to, what became popularly known as "Agent Orange". If DOD had a record of AO being used in a particular area, then your chances of being treated, improved.

If, however, you were in an area (Laos, Cambodia) that we were not "officially" in, you were toast, because your DD-

214 didn't show that you were "there".

After many years of not providing our veterans with the care that they were legally entitled to, our current Secretary of Veterans Affairs, Eric Shinseki (Retired General), allowed as how that if you took one step into Vietnam, you were "presumed" to have come in contact with AO. This, of course, led to a dramatic increase in the number of claims being filed, which slowed the process. However, many veterans never got the word that they were not able to file their claims, so have gone untreated, or died. The plot thickens.

What about those who served in the Blue Water Navy? Why are they showing the symptoms of AO, even though they never stepped foot on land, while serving off the coast?

Large Navy ships have "evaporators", which take in seawater, and render it mineral-free, to allow it's use in the ship's boilers.

Except that a study by the Australian and French governments, found that the dioxins were not only NOT eliminated during the desalinization of seawater, but actually caused it to be concentrated.

What does this mean?

Well, the guys on ships were cooking with AO contaminated water, showering with it, brushing their teeth with it, and drinking it.

What can we do?

We need to educate our local, state and federal representatives! There are many new faces in our collective legislatures, and they've not acquired this vital information by osmosis. We need to tell them!

Right now, we're fortunate that politicians, Democrat, Republican or Independent, are falling all over themselves to show that "we support our veterans!".

We MUST take advantage of this! We MUST strike while the iron is hot!

OK, what do YOU have to do?

Get down to your nearest VA clinic, and find out who doctor in charge of the AGENT ORANGE REGISTRY is, then go there with your DD-214 in hand.

If you don't get any satisfactory results there, contact your County Veterans Service Officer. If you have a Veterans Service Office, they are also a good source of assistance. Or, contact your local VVA chapter, to find out if there's VVA VSO to contact.

Other hazards experienced by our veterans, include the first Gulf War. Remember the infamous Weapons of Mass Destruction (WMDs)? What didn't make it to Syria, were dumped into the Iraqi-built tank traps.

The traps were filled with oil, and set ablaze. The aroma of burning mustard, sarin and whatever else Saddam was using against his own people must have been scintillating! After Stormin' Norman chased the Republican Guard out of Kuwait, remember what the Iraqis did to the oil fields? They set them on fire! Burning petroleum is TOXIC! How about now?
